# Outdoor Sport Facility Terms and Conditions

<b>RENTAL FEES:</b>	The City of Richmond charges a rental fee for the use of both City and School District #38 outdoor sport facilities. Please refer to the fee schedule that is attached to this document for a listing of the outdoor sport facility fees. <b><i>Fees for use of Facilities may increase over time, to cover inflationary increases in Facility operating costs, in compliance with the City's fees and charges bylaw process.</i></b>										
<b>PAYMENT:</b>	<p><u>One Time Bookings</u>: Payment is due in full at time of booking.</p> <p><u>Block Bookings</u>: Payment is due in full upon contract confirmation.</p> <p>Payment can be made using cash, cheque, debit or a credit card.</p> <p>Cheques are payable to the 'City of Richmond'. A \$39.00 fee is charged for NSF cheques.</p>										
<b>INSURANCE:</b>	All groups must purchase and provide proof of comprehensive general liability insurance. Groups must forward a copy of their insurance certificate, which shows the type of insurance, the expiry date, the amount of coverage (minimum \$5,000,000) and a statement naming the 'City of Richmond' and 'School District #38 (Richmond)' as additional insured.										
<b>CANCELLATIONS BY THE RENTER:</b>	No refund will be issued if less than seven calendar days notice is given. If more than seven calendar days notice is given a refund will be returned to the renter upon receipt of written notice of the cancellation.										
<b>CANCELLATIONS BY THE CITY:</b>	The City reserves the right to cancel, postpone or reschedule a rental slot.										
<b>FIELD CLOSURES:</b>	<p>There are times when it becomes necessary to close fields during extreme weather conditions and maintenance. The field closure information is updated weekdays before 2pm. The Friday field report is in affect for the entire weekend. <b>TOURNAMENTS:</b>	Contact the Events/Rentals office with details to determine if your tournament requires an event application to be submitted.										
<b>PRIORITIES OF OUTDOOR SPORT FACILITY ALLOCATION:</b>	<p><b><i>It is the City's position that Richmond's affiliated community groups holding current allotments will receive first priority for the same allotments each year. Membership must be comprised of 70% or more Richmond residents to qualify as a Richmond affiliated community group.</i></b> The City reserves the right to request a list of participant's names and addresses to verify that groups meet this residency requirement. # Outdoor Sport Facility Terms and Conditions

## CODE OF CONDUCT:

As a responsible user of the City of Richmond and School District #38 (Richmond) outdoor sports facilities, all leagues/teams/individuals are expected to follow these guidelines:

- The consumption of alcohol and/or illegal drugs is not permitted.
- No smoking (including tobacco, cannabis, and all vapour products) at public parks and school grounds. This includes playing fields, playgrounds, and trails.
- Players, coaches and team supporters must be courteous and respectful to residents, other park users, caretakers, City staff and other agencies at all times.
- Use designated washroom facilities. Access to school washrooms is **not** permitted.
- Obey all traffic and parking signs, regulations, by-laws and conditions.
- Pick-up and remove all litter generated while using the park
- Respect and protect public and private property.
- Obey City of Richmond Park by-laws and regulations.
- Lighting of fields, diamonds, tennis, basketball and lacrosse box is permitted until 11:00pm (exceptions London, Richmond High and Hugh Boyd Park the lights are shut-off no later than 10:30 pm). Written authorization is required from the Parks Department for use beyond 11:00 pm.
- Pick-up after your pets (dogs must be on leash at all times).
- Sport facility access is limited to your assigned allocation times as noted on your group's rental contract. Permit holders are allowed onto their assigned area at their contract start time. All users must leave the area by the end time on your contract.
- The applicant will not sublet the use of their allotted sport facility time to any person, group or organization not named on the rental contract to use or occupy the field without the City of Richmond's written consent.

## ARTIFICIAL TURF CONDUCT:

In addition to the above, the following conditions specific to using the artificial turf must be adhered to at all times:

- No food or beverages except water
- No gum, sunflower seeds, or tobacco products
- No pets
- No portable practice nets (without prior approval)
- No metal cleats or track spikes are permitted.
- Spectators: All spectators must remain outside the fenced area. The playing field and sidelines are for players, coaches, officials and medical personnel only.

## CODE OF CONDUCT VIOLATIONS:

The City of Richmond and the R.C.M.P. have agreed on procedures for dealing with groups that disregard the above Terms and Conditions and Code of Conduct.
