Municipal and other taxing agency services such as the Province of BC (School tax), TransLink, BC Assessment Authority, Metro Vancouver and the Municipal Finance Authority have been defined as essential by the Province of BC during the COVID-19 pandemic.

These services will continue to operate and additional taxpayer relief measures have been provided:

- A) The Province of BC has:
 - Postponed the date for late payment penalties for commercial properties (Class 4, 5, 6, 7 and 8) to after September 30, 2020.
 - Reduced school property taxes for commercial properties, resulting in an approximate 25% reduction in overall property taxes for the 2020 tax year.
- B) The City of Richmond has:
 - Moved the property tax penalty date to apply to payments after September 30, 2020 to increase payment flexibility for <u>all other</u> property classes.
 - Reduced the Municipal tax increase from 4.98% to 2.97%.

What's new in Tax Deferment in 2020

The Province of BC has made changes to the application and renewal process for the property tax deferment program:

- Residential property owners must apply online for property tax deferment on their principal residence and for the first time, owners can choose to auto renew their application.
- The new online application process will allow for a quicker application review and the new auto renewal option will allow BC property owners to receive the benefits of the program sooner.
- The City will no longer be accepting deferment applications. The Province has assumed responsibility and oversight with deferment applications.
- Property owners should still apply for their home owner grant and pay taxes owing from previous years, penalties or interest prior to submitting a deferment application or renewal.
- Current programs that continue to be available are:
 - 1. Regular Property Tax Deferment Program for:
 - Owners age 55 or older in the current year
 - A surviving spouse of any age
 - A person with disabilities
 - 2. Families with Children Tax Deferment Program

2. At your financial institution

- Via internet or telephone banking, bank machine/ATM or in person.
- Financial institutions will not accept your home owner grant application forms.
- Please allow a minimum of two business days for your payment to reach us.

3. By mail

- Make sure you mail your cheque early and leave extra time for delivery.
- Postmarks are not accepted as proof of on-time payment.
- Mail lost or delayed by the post office will be subject to penalty.
- Write your folio number on the front of the cheque.
- Cheques can be postdated to the due date and sent with the home owner grant to:

4. In the drop box at Richmond City Hall

- 6911 No. 3 Road (located at the west entrance).
- Payments dropped off after midnight on September 30, 2020 will be subject to a penalty.
- Do not deposit cash, as cash will not be processed.



5. Due to the COVID-19 pandemic, City Hall may be closed to the public or on reduced hours until further notice. Please check online for hours of operation.

- Credit card and mobile payments are charged a service fee of 1.75%.
- The City will not accept cash payments:
 - until after September 30, 2020 (date may be extended pending any Provincial Health advisories).
 - of \$10,000 or greater.



6. Pre-authorized withdrawals (PAWS)

Maximize the benefits of **prepaying your 2021 property taxes**, by submitting your form before Thursday, July 16, 2020.

This program offers fixed monthly payments and interest on your money.

The current year's taxes must be paid on or before the due date before making a PAWS application.

How to reduce payment by claiming a home owner grant

The home owner grant threshold for 2020 is \$1,525,000. The grant is reduced for assessment values over this amount. If eligible, property owners must claim the grant every year before the due date.

If eligible, claim your home owner grant annually (from quickest to slowest):

1. Online: Through the City's secure website at www.richmond.ca/homeownergrant

Please retain the confirmation number as a receipt of the application.

2. By mail: Complete the application in full on the bottom of the tax notice and mail to:

3. In person: Complete the application in full on the bottom of the tax notice and submit it in the drop box at City Hall.

How to defer taxes

The Province of BC's property tax deferment program is a low interest loan designed to help qualified BC home owners pay their annual property taxes.

Two options available are:

 - A person with disabilities
- 2. Families with Children Tax Deferment Program



Penalties on unpaid taxes




A 10% penalty is applicable to current unpaid taxes after **September 30, 2020**.
