#### **Staff Report**

## Origin

Pursuant to Section 168 (1) of the Community Charter, the total remuneration, benefits and expenses incurred by each member of Council must be reported annually.

### **Analysis**

Total salaries paid to Council members for 2018 were \$676,422 and the cost of benefits was \$153,073. Total expenses incurred were \$26,262. The schedule below provides a summary by each member of Council.
