12.5 Industrial Storage (IS, IS1) [Bylaw 8634, Sep 27/10]

12.5.1 Purpose

The **zone** provides for storage and shipping **uses**. The **zone** is divided into 2 sub-zones: IS for sites used for storage, shipping and industrial uses; IS1 for sites used for commercial vehicle parking and storage and outdoor storage uses only. [Bylaw 8634, Sep 27/10]

12.5.3 Secondary Uses

residential security/operator unit

12.5.2 Permitted Uses

- child care
- commercial vehicle parking and storage [Bylaw 8582, Apr. 19/10]
- industrial, general
- outdoor storage
- [Bylaw 8582, Apr. 19/10]
- transportation depot
- truck or rail terminal

12.5.4 Permitted Density

- The maximum floor area ratio is: [Bylaw 8634, Sep 27/10] 1.
 - 1.0 for sites zoned IS; [Bylaw 8634, Sep 27/10] a)
 - 0.08 for **sites** zoned IS1. [Bylaw 8634, Sep 27/10] b)

12.5.5 Permitted Lot Coverage

- The maximum lot coverage is: [Bylaw 8634, Sep 27/10] 1.
 - 50 % for buildings on sites zoned IS; [Bylaw 8634, Sep 27/10] a)
 - 8% for sites zoned IS1. [Bylaw 8634, Sep 27/10] b)

12.5.6 Yards & Setbacks

- 1. The minimum front yard and exterior side yard is 6.0 m.
- 2. There is no minimum interior side yard or rear yard.

12.5.7 Permitted Heights

- 1. The maximum **height** for **buildings** is 12.0 m.
- 2. The maximum **height** for **accessory structures** is 20.0 m.
- **Commercial vehicle parking and storage** and **outdoor storage uses** are not permitted to be stored, stacked or piled in any manner that exceeds 4.5 m in height. [Bylaw 8634, Sep 27/10] 3.

12.5.8 Subdivision Provisions/Minimum Lot Size

1. There are no minimum lot width, lot depth or lot area requirements.

12.5.9 Landscaping & Screening

- 1. **Landscaping** and **screening** shall be provided according to the provision of Section 6.0.
- 2. **Landscaping** and **screening** shall consist of a 3.0 m wide landscape **screen** and a **fence** situated along the **road frontage** for **sites** zoned IS1. [Bylaw 8634, Sep 27/10]

12.5.10 On-Site Parking and Loading

1. On-site **vehicle** and bicycle parking and loading shall be provided according to the standards set out in Section 7.0.

12.5.11 Other Regulations

- 1. In addition to the regulations listed above, the General Development Regulations in Section 4.0 and the Specific Use Regulations in Section 5.0 apply.
- 2. The following are **permitted uses** for **sites** zoned IS1 subject to the restrictions in Section 12.5.11.3: [Bylaw 8634, Sep 27/10]
 - a) commercial vehicle parking and storage; [Bylaw 8634, Sep 27/10]
 - b) **outdoor storage**; [Bylaw 8634, Sep 27/10]
 - c) residential security/operator unit. [Bylaw 8634, Sep 27/10]
- 3. The following are prohibited from occurring on **sites** zoned IS1: [Bylaw 8634, Sep 27/10]
 - a) Outdoor storage of wrecked or salvaged goods and materials; [Bylaw 8634, Sep 27/10]
 - b) Outdoor storage of food products; [Bylaw 8634, Sep 27/10]
 - c) **Outdoor storage** of goods or materials that are capable of being transmitted above, across or below a land or water surface due to the effects of weather; [Bylaw 8634, Sep 27/10]
 - d) **Outdoor storage** of goods or materials that constitute a health, fire, explosion or safety hazard; [Bylaw 8634, Sep 27/10]
 - e) Producing, discharging or emitting odiferous, toxic, noxious matter or vapours, effluents, heat, glare, radiation, noise, electrical interference or vibrations; or [Bylaw 8634, Sep 27/10]
 - f) servicing of **vehicles** or equipment. [Bylaw 8634, Sep 27/10]
