


2. Richmond Zoning Bylaw 8500, Amendment Bylaw 10565 (RZ 23-023857)




3. Richmond Zoning Bylaw 8500, Amendment Bylaw 10578 (RZ 21-934592)

Location/s: 8240 Williams Road

Applicant/s: Asteria Properties Inc.

- **Purpose:** To rezone the subject property to the "Low Density Townhouses (RTL4)" zone, to permit development of three townhouse units, with vehicle access off Williams Road.
