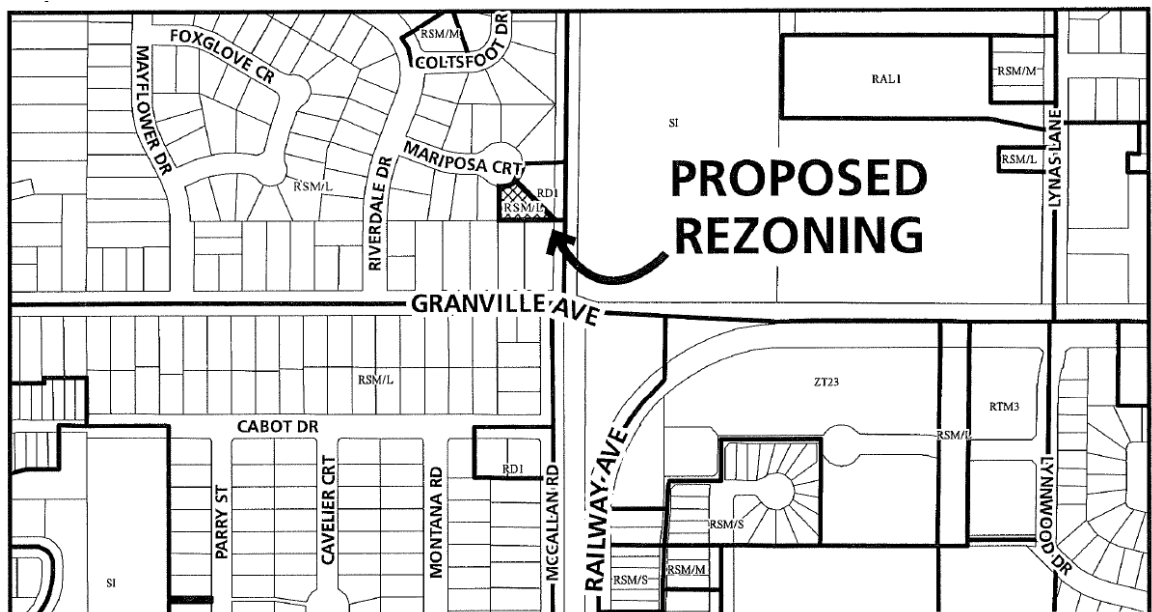
1. **RICHMOND ZONING BYLAW 8500, AMENDMENT BYLAW 10722 (RZ 21-938608)**

Location/s: 4920 and 4940 Mariposa Court

Applicant/s: Rav Bains

Purpose: To rezone the subject property from the “Small-Scale Multi-Unit Housing (RSM/L)” zone to the “Small-Scale Multi-Unit Housing (RSM/M)” zone to permit the property to be subdivided into new lots, each lot containing a proposed single-family home and a secondary suite, with access from Mariposa Court.

Purpose: To amend Richmond Zoning Bylaw 8500 to clarify setback provisions associated with Small-Scale Multi-Unit Housing and amend the definition of a principal dwelling unit.
