Development Cost Charges and School Site Acquisition Charge – Building Permit Applications for Small-Scale Multi-Unit Housing No.: DEVAPPS-19 Date: 2025-04-08

Purpose

To inform all applicants for Small-Scale Multi-Unit Housing (SSMUH) Building Permits about the Development Cost Charges (DCC) and School Acquisition Charge (SSAC) payable at issuance of Building Permits.

Background

In response to the Province of British Columbia's amendments to the *Local Government Act* (Bill 44), Richmond Council amending the zoning bylaw of almost 27,000 single-family and duplex lots throughout the City to permit SSMUH developments.

As a result of introducing a new form of development within the City, DCCs and SSAC at Building Permit will be assessed for SSMUH developments.

In accordance with *Development Cost Charges (DCC) Imposition Bylaw No. 9499* in effect, City of Richmond DCCs at Building Permit are currently not imposed for SSMUH developments. However, DCCs and SSAC collected by the City on behalf of TransLink, Metro Vancouver and School District No. 38 may be applicable and imposed at Building Permit.

The process of reviewing City DCC rates for all forms of development in response to Bill 44 and Bill 46 is under way.

Impacts on infrastructure and required upgrades, as well as impacts on parks, recreation and cultural facilities, and other amenities is under review.
