*That support be given to an alternative arrangement to accept 0.60 cents per buildable square foot under the interim policy for the project to secure entry level ownership units at 6600, 6620 Cooney Road and 6591, 6611 Eckersley Road.*

The question on the motion was not called, as support was offered by Committee members for the proposed motion. Discussion then ensued among Committee members and staff on matters relating to affordable housing, including:

- the amount of funds currently in the Affordable Housing Strategy account, and how the affordable housing contributions received were distributed between the capital reserve and operating reserve affordable housing accounts
- concerns about the clause in the affordable housing policy that units would only be designated as affordable for 18 months and then revert to market housing
- strategy equity in the contributions from various housing densities and how this was being addressed through the affordable housing policy
- the difficulties faced by families who were asset rich but income poor, and how the City would be dealing with this issue; and whether a possible solution to this issue would be to concentrate on a rental program
- the project now being considered as it related to the City's Affordable Housing Strategy
- the Affordable Housing Strategy as it related to the number of units being proposed; the proposed cash contribution and making good use of the funds being provided.

The question on the motion was then called, and it was **CARRIED**.
