

## **Guideline: Mobile Home Applications**

Must be a home that is **completely** CAN/CSA approved, to Z-240 MH Series-M86 "Mobile Homes" and CSA A277-M1990 "Procedures for Certification of Factory Built Houses" (modular homes).

Applicant must have Certification Form, signed by an authorized representative of the **manufacturer** and returned, prior to issuance of a building permit. (see attached)

**Permitted Location:** Any residential or agricultural area, which may be subject to specific Zoning Bylaw restrictions. Example: E.S.A. – Environmentally Sensitive Area

N.E.F. – Noise Exposure Forecast

B.E.R. – Building Elevation Restriction, floodplain

Factory built housing will be treated like any other house:

- (a) Proper footings if on peat or over 6 in. of fill, a Geotechnical Engineer is required and a Structural Engineer may be required.
- (b) Conformance with current BC Building Code and applicable local Bylaws.

Provide two copies of the following drawings:

(a) Site plan showing: • location of home on lot in relation to property lines and all other structures.

> • city utilities such as water, storm and sanitary sewer locations.

• driveway crossing.

(b) Floor plans showing: • room sizes, use, door and window sizes.

• heating type, plumbing fixtures.

• exterior landing, stairs, handrails, etc.

•"tie down" method. (c) Foundation plan/details:

(to be signed by a Structural Engineer) • size and type of footing.

• connection details of modules

• specifying the materials used in the construction of the unit. (d) Cross section:

(e) Elevations: • exterior appearance including exterior landing, stairs, etc.

> • window location and size to be indicated to calculate spatial separation from property lines and other buildings.
