- A copy of your current ICBC vehicle registration papers for each vehicle bearing a Veteran plate, must accompany this application.
- Your application will be processed within 5 business days at which time you will be automatically entered into the program.
- No decal is required. Your ICBC issued Veteran licence plate is recognized by the City of Richmond's Licence Plate Recognition Program (LPR) as exempt for payment at City owned Meters.
- There is no fee for the program and your exemption is automatically renewed each year if you continue to meet the eligibility requirements.

Before applying, please read the following carefully

1. General

Exemptions for pay parking issued by the City of Richmond (the "City") are subject to the following terms and conditions. These terms and conditions are subject to change without notice.

2. Liability

The City assumes no responsibility for injury, death, property damage, theft or loss of or to persons or vehicles occurring in or around the parking area.

3. Assignment

No payment is required at all City of Richmond on-street parking meters and at City of Richmond off-street lots located at Gateway Theatre, Bowling Green and Brighthouse Park.

4. Valid

- The exemption is valid year-round for all vehicle owners possessing **Veterans Licence Plates** available through ICBC and who are residents of the City of Richmond only.
- Applicants that no longer reside in the City of Richmond will be removed from the program.
- Any vehicles not registered with the Veteran Parking Program, will be subject to normal enforcement¹.
- It is the responsibility of the registered owner of the vehicle(s) to advise Community Bylaws if new or replacement licence plates have been issued to your vehicles.
- Two hour maximum parking.
